

**GREENWOOD BAPTIST CHURCH  
LIABILITY RELEASE FORM TOP ARTICIPATE IN  
YOUTH ACTIVTIES AND/OR FIELD TRIPS**

In consideration for being accepted by *Greenwood Baptist Church* (the Church) for participation in **Youth Activities for the calendar year of 2021 within the United States**, we (I), being 21 years of age or older, do hereby release, forever discharge and agree to hold harmless *Greenwood Baptist Church* and the directors, of any nature whatsoever which may be incurred by the undersigned and the child-participant that occur while said child is participating in the above described trip or activity.

We (I) hereby agree as follows:

1. We (I) assume full legal and financial responsibility for my child's participation in the activity.
2. We (I) grant the church, its employees, agents, and representatives the authority to act in any attempt to safeguard and preserve my child's health or safety during his or her participation in the field trip/activity including authorizing medical treatment on my behalf and at my expense and returning my child home at my own expense for medical treatment or in case of an emergency.
3. Accident and health insurance are recommended for my child's participation in this field trip/activity. I understand that Greenwood Baptist Church encourages me to have appropriate insurance coverage for the entire time of the field trip/activity.
4. I shall conform to all applicable policies, rules, regulations, and standards of conduct as established by the Church to ensure the best interest, comfort, and welfare of the trip.
5. I voluntarily indemnify and hold harmless the Church, Board, Employees, Independent Contractors, Volunteers, respective officers, and agents from any and all liability, loss, personal injury, sickness, or death, as well as property damages, costs, or expenses, of any natures (including attorney's fees) whatsoever arising out of my child's participation in the field trip/activity and which do not arise out of negligent acts or omission of an officer, employee, and agent of the Church, Board, employees, independent contractors, and volunteers, while acting within the scope of their employment or duties from the Church.
6. We (I) grant permission for my child to be at any and all activities and field trips that take place in 2022 regardless of location, which include, but are not limited to the physical property of the church facility, the home(s) of Church members, Board members, Employees, Independent Contractors, or Volunteers,

and other locations both within the state of Georgia, and outside of the state of Georgia, and shall not hold liable the church, nor any of its members, Board members, Employees, Independent Contractors, or Volunteers, for any and all incidents resulting in personal injury, sickness, or death, as well as property damages, costs, or expenses, of any natures (including attorney's fees) whatsoever arising out of my child's participation in the field trip/activity, regardless of location.

I understand that I am waiving and releasing any right of the child and any right that ANY parent or guardian might have to sue or make claim against Greenwood Baptist Church, its members, Board members, Employees, Independent Contractors, or Volunteers for any act or omission, event or injury the child might sustain during the course of or arising out of the Activity or Field Trip.

I agree that if any court of competent jurisdiction shall declare any provisions of this agreement to be unenforceable in any respect, such unenforceability shall not affect any other provision of this agreement, and this agreement shall be construed as if such unenforceable provision or provisions had never been contained herein,
- 9, **I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS AGREEMENT INCLUDES A WAIVER OF LIABILITY AND RELEASE, AN ASSUMPTION OF RISK, AND AN AGREEMENT BY ME TO INDEMNIFY THEIR LEASEES, AND I SIGN IT OF MY OWN FREE WILL.**
